That section provides that a person will be deemed to hold a relevant interest in any securities that a body corporate has a relevant interest in where the person's voting power in that body corporate is above 20%. Brickworks has voting power in WHSP of 42.715%. As such, Brickworks is deemed to have a relevant interest in securities held by WHSP in the Company.
